## Public Notice

**To: Property Owners within FrankenlustTwp., Bay County, Michigan**

The owner(s) of land in Frankenlust Township on which noxious weeds are found growing must destroy them before they reach a seed-bearing stage and prevent their re-growth, or must prevent them from becoming a detriment to public health. Such weeds must be cut and the land may be treated with safe chemicals approved for eradicating them. Weeds not cut by July 1, 2006 may be cut by the Township. The Township may cut weeds as many times as necessary. All expenses incurred by the Township in cutting shall be paid by the owner of the land. The Township will have a lien against the land for its total expense of cutting. The lien may be enforced by foreclosure.

Well, it was so good to see the rain. It sure has made everything perk up and grow.

Your tax bills arrive again in early July. Remember due to a change in state law, two-thirds of the county allocated operating millage will be shifted to the July 2006 property tax bill which would normally be on the December 2006 tax bill.

Letters for deferments will again be sent around the middle of July for those who are eligible. I know after I mailed out the deferments last year they did end up changing the amount to \$25,000 for gross income; so be sure to read your letter in case there are any new changes again this year.
